MOTION TO ADOPT A ZONING ORDINANCE FOR
SUGARCREEK BOROUGH, VENANGO COUNTY, PENNSYLVANIA

WHEREAS, The Borough Council of Sugarcreek Borough requested the Planning and Zoning Commission for the Borough of Sugarcreek to prepare several amendments to the Zoning Ordinance of the Borough of Sugarcreek which was approved the 13th day of June 1969; and

WHEREAS, The said Planning and Zoning Commission for the Borough of Sugarcreek prepared the proposed amendments to the said Ordinance and presented them to the Borough of Sugarcreek Council on *Mar. 16, 1970*; and

WHEREAS, The Borough Council of the Borough of Sugarcreek held a public hearing on the proposed amendments to the Zoning Ordinance, which said public hearing was held on June 23, 1970, at 7:30 o'clock, P.M., EDST, at the Rocky Grove Fire Hall, Wood Street, Rocky Grove, Borough of Sugarcreek; and

WHEREAS, The proposed amendments and the notice of the public hearing thereon were published in the News-Herald, a newspaper of general circulation in the Borough of Sugarcreek, on June 2 and June 9, 1970; and

WHEREAS, At said public hearing announcement was made by the Council of the Borough of Sugarcreek that the said amendments to the Zoning Ordinance would be considered at the next regular meeting of the Borough Council, which would be July 6, 1970, at the Borough Building, Fox Street, Rocky Grove, at 7:30 o'clock, P.M.; and

WHEREAS, I hereby attach to this Motion the proposed amendments to the Zoning Ordinance which I propose to have adopted and which proposed amendments to the Zoning Ordinance has attached to it the Sugarcreek Borough Zoning Map, as amended, as a part of this Ordinance; and

WHEREAS, It is now my intention to have the said Borough Council consider the adoption of the amendments to the Sugarcreek Borough Zoning Ordinance and the corresponding amendments to the official Zoning Map of the Borough of Sugarcreek.

I, therefore, this 6th day of July, 1970, move for the adoption of the hereto attached amendments to the Sugarcreek Borough Zoning Ordinance and official Zoning Map as prepared by the Sugarcreek Borough Planning and Zoning Commission, as amended or altered by the Sugarcreek Borough Council after the public hearing held by the Sugarcreek Borough Council on June 23, 1970, and

I further move that said amendments to the Ordinance shall be incorporated into the official Ordinance Books of the Borough of Sugarcreek and into the official Zoning Ordinance of the Borough of Sugarcreek, by reference and with the same force and effect as if the amendments to the Zoning Ordinance and official Zoning Map were duly recorded therein.
